MEMBERS ONLY CAR DRAW

- At least 4 car draws will take place per year.
- To be included in Car Draw, Payment must be made in advance of draw.
- Annual subscription €60.
- Members must complete attached authorisation form and post or hand it in to your Credit Union Office.
- €60 will be deducted from your savings when you join the draw and annually thereafter unless otherwise notified.
- In the event of a member joining after the start of the draw pro-rata rate will apply.

MEMBERS ONLY CAR DRAW RULES

- The draw will commence at AGM 2007 and will continue thereafter until the Board of Directors of Castleblayney Credit Union (here after called the Board of Directors) deem otherwise.
- Participation in the draw is limited to eligible members of Castleblayney Credit Union Limited and they must be over 18 years of age on or before the draw date.
- Winning members will be notified personally.
- The entrance fee of €60 per annum per member will be deducted in advance from savings or as defined from time to time by the Board of Directors.
- Any member with insufficient funds in their account at that date will be deemed ineligible to participate.
- Draws will be ordinarily held in the Credit Union offices under the supervision of at least one member of the Board of Directors and one independent observer, a member of An Garda Síochána.
- Entry is limited to members only; both names on a joint account will be deemed to be equal owners. Both names on a joint account must sign authorisation for inclusion in the draw.
- A Register of entrants will be maintained at the Credit Union offices for inspection.
- Authorisation for inclusion in the draw must be completed prior to participation and no entry is valid unless full fees are paid and credited in advance.

- Financial Accounts of the draw fund will be audited at each year end.
- The Board of Directors may decide to give the winners cash towards the purchase of a new car.
- Each winner will receive €16,000 towards the purchase of a new car.
- Annual subscription may be changed for future draws at the discretion of the Board of Directors.
- The decision of the Board of Directors of Castleblayney Credit Union concerning the foregoing rules or any matter arising from the draw held will be final and not subject to appeal.
- The draw will be self-financing and any additional funds will be disposed of by way of an extra draw or draws.
